WHEREAS, in terms of section 15 (3)(a) of the NCTE Act 1993, WRC had granted permission to SRI SATYA SAI COLLEGE OF PHYSICAL EDUCATION, RUN BY VAISHNAV EDUCATION SOCIETY, AT PANCHAMA SEHORE, MADHYA PRADESH for B.P.Ed. course vide order dated 03.09.2008 for an annual intake of 50 seats.

AND WHEREAS, WRC issued Revised Recognition Order to SRI SATYA SAI COLLEGE OF PHYSICAL EDUCATION, RUN BY VAISHNAV EDUCATION SOCIETY, AT PANCHAMA SEHORE, MADHYA PRADESH vide order dated 20.05.2015 for conducting B.P.ED. course of two year duration with an annual intake of 100 students (one basic unit with two sections of 50 (fifty) each) from the academic session 2015-2016.

AND WHEREAS, the institution applied for change of name from Sri Satya Sai College of Physical Education, Sehore to School of Physical Education, Sri Satya Sai University of Technology & Medical Sciences, Sehore.

AND WHEREAS, the matter was placed in 237<sup>th</sup> Meeting of WRC held on December 21-22, 2015 and the Committee decided that "...Sri Satya Sai Institute of Education, Sehore, M.P. has applied for changing the names of three institutions - Sri Satya Sai College of Education, Sehore; Sri Satya Sai Institute of Teacher Education, Sehore; and Sri Satya Sai College of Physical Education, Sehore. Under the M.P. Private Universities Regulatory Commission letter dated 22.09.2014, the affiliations of these colleges has been changed from Barkatullah University to Sri Satya Sai University of Technology & Medical Sciences (SSSUTMS). The institution has deposited the fee for change of name as per the old Regulations. As per the new Regulations, the required amount is Rs.1.50 lakhs for each change of name. As soon as the difference of amount is received by RD, he may issue the order permitting the change of name."

AND WHEREAS, the institution vide letter dated 24.12.2015 has deposited the required fee.

NOW THEREFORE, the permission is hereby granted for change of name of the institution from Sri Satya Sai College of Physical Education, Sehore, Madhya Pradesh to School of Physical Education, Sri Satya Sai University of Technology & Medical Sciences, Sehore, Madhya Pradesh.
