Report of the Inspection committee on its visit to Proposed University, on 22nd September, 2015

- Introduction: On the recommendation of the Madhya Pradesh Private Universities Regulatory Commission, Bhopal vide letter no. 1168 dated 19/09/2013, the Madhya Pradesh Government vide its letter no. 3107/468/CC/13-38, dated 04/10/2013 has issued letter of Intent (LOI) to M/s G.H.R Sons Educational and Medical Research Foundation for establishment of a private university namely G.H.Raisoni Technical and Management University at Dhodaborgaon, Tahsil: Saunsar, District: Chhindwada, Madhya Pradesh. The society has submitted its compliance report to the regulatory commission vide letter no. GHRSEMRF/CR/2015-16/37, dated 30/07/2015, accordingly, the Chairman, Regulatory commission vide letter no. 972/MPPURC/Bhopal dated 10/09/2015 has constituted an expert committee to assess and verify the physical infrastructure for the proposed University.
- II. Background of the Society: M/s G.H.R Sons Educational and Medical Research Foundation is a not for profit organisation established by Raisoni Group. Raisoni Group of Institutions (RGI) has a glorious history of 2 decades of existence in Central India, it had started in 1998, Raisoni Group of Institutions has grown into one of the leading educational groups in Maharashtra. RGI is one of Central India's largest and premier groups of education institutes. RGI offer courses right from KG to 12th, undergraduate, and post graduate to professional courses such as management, Engineering, law, MCA, Polytechnic, Commerce, Science, etc. They have 31 institutions spread across Nagpur, Pune, Amravati, Amhednagar, Jalgaon and Raipur.
- III. Objectives of the Proposed University: To achieve excellent standard in quality education by keeping pace with rapidly changing technologies and to create technical man power of Global Standard with capability of accepting new challenges. To impart quality and

VI. Observation of the Committee: -

The Committee during its visit observed that the proposed university complied with all the mandatory stipulations of the "M. P. Government Private University (Establishment and Regulation) Act 2007". The area of building constructed till date is more than 7500 Sq. Mtrs., which is exceeding the mandatory requirement. The Endowment fund of Rs. 5 Crores has already been deposited in October 2013. The Society has very sound academic background as it is already running highly successful academic institutions numbering thirty one for the last two decades.
