- (d) secured overall CGPA of 6.5 ; In case, a student secures less than overall CGPA of 6.5, but not less than 5.0 ; s/he will be awarded a B.A (Pass) degree. A student will have to obtain at least a minimum GPA of 5.0 in each individual subject.
- (e) No dues to the University, Hostels, Libraries, NCC/NSS/NSO etc.

And

no disciplinary action is pending against her/him.

9. Attendance requirement

A candidate must have at least 75% attendance. On medical ground, it may be relaxed as admissible within applicable regulations.

2. **Name of Faculty** School of Humanities and Literary Studies
3. **Duration of the Course** Minimum 2 years (4 semesters)
Maximum 3 years (6 semesters)
4. **Minimum Eligibility** Candidate who has passed a graduate program in any subject from any recognized university or holds an equivalent degree from any recognized institution with at least 45% of marks.
5. **Admission Procedure** On merit, on the basis of the qualifying examination / entrance examination following norms of the concerned regulatory body UGC and approved by Admission Board of ITM University.

OR

Final examination of the two year course of the Joint Services Wing of the national Defence Academy.

OR

General Certificate Education (GCE) Examination (London-Cambridge/Sri Lanka) at the advanced (A) Level.

OR

Any Public School/Board/University examination in India or in any foreign Country recognized as equivalent to 10+2.

OR

Senior Secondary School Examination conducted by the National Open schooling with a minimum of five subjects

OR

Statutory body will be UGC.

And

Candidates should have at least 50% marks in the aggregate in the qualifying examination (10+2).

5. Admission Procedure
