PEOPLE'S UNIVERSITY, BHOPAL
Established under M. P. Act No. 17 of 2007
Ordinance No. 31
MASTER OF TECHNOLOGY (M. TECH.)

This ordinance shall be applicable for master degree course in technology and shall follow the norms laid down by AICTE.

1.0 AIM and objectives :

- 1.1 To offer advanced programmes and courses to the graduates to specialize in particular field of Engineering.
- 1.2 To inculcate the specialized skills to meet the demand of rapidly growing Technology.
- 1.3 To orient the graduates to judiciously apply theoretical knowledge in effective practical management of various associated problems.

2.0 Applicability :

This ordinance shall apply to all the programmes and courses leading to the award of post graduate degree of Master in Technology (M. Tech.)

3.0 Definitions :

- 3.1 Academic Programme/Programmes shall mean a programme of courses and/or any other component leading to a Master's Degree in Technology.
- 3.2 Academic Year is a period of 12 months devoted for the completion of requirement specified in the scheme of teaching and the related examinations.
- 3.3 Course means an academic programme and/or component, carrying a distinctive code and specific credits assigned to it.
- 3.4 University shall mean People's University, Bhopal Madhya Pradesh.
- 3.5 Semester System—A programme wherein each academic year is appointed into two parts know as semesters.
- 3.6 Student shall mean a person admitted and enrolled for a programme in the Instituted School of the University which is constituent unit.
- 3.7 Ex-student shall mean those students who are not eligible for promotion/admission to higher semester due to short -fall in academic standards/attendance.
- 3.8 External Examiner shall mean an examiner who is not in the employment of the University.

4.0 Admission :

4.1 Candidates possessing following qualifications shall be eligible for admission :

- 4.1.1 Regular fulltime B. E./B. Tech. and with minimum CGPA of 5.0 or 50% marks in aggregate.
or
- 4.1.2 Candidates possessing associate membership of professional bodies (AMIE and IME) in the discipline of the concerned degree.
or
- 4.1.4 M. Sc. in relevant subject with minimum CGPA of 5.0 or 50% marks in aggregate.

4.2 Admissions shall be according to the following Criteria—

- 4.2.1 Merit prepared on the basis of valid GATE score.
or
4.2.2 Merit prepared on the basis of test conducted by University or an Agency on its behalf.
or
4.2.3 Merit prepared on the basis of CGPA or marks obtained in the qualifying examination and subject to qualifying in personal interview conducted by the University with a provision that seats shall be first filled by candidates possessing BE/B Tech./AMIE degrees before offering them to others.
- 4.3 Candidate who has already appeared in last (i.e.VIII) semester examination of Bachelor of Engineering (BE)/Bachelor of Technology (B.Tech) may be considered for admission, if he/she has successfully passed, I to VII Semester examinations of BE/B. Tech. Such candidate shall be admitted provisionally and shall be required to submit, certificate and mark-sheet as proof of passing qualifying examination within three months of commencement of the course. Otherwise his/her admission will be cancelled. Such candidate can not claim for refund of fees.

5.0 Duration :

- 5.1 Master of Technology shall be a fulltime Post-graduate Degree programme of two academic years (i.e. four semesters) including examinations, commencing from July every year.
- 5.2 Maximum period for completion of M.Tech. Course shall be of five years from the date of commencement of the Course.
- 5.3 Non-appearance at an examination on grounds of sickness or otherwise, will be treated as one attempt.

6.0 Medium of Instruction :

- 6.1 English shall be medium of instructions, examination and dissertation.

7.0 Attendance :

- 7.1 Regular students are required to attend a minimum of 75% theory classes and 80% practical classes separately in a semester to be eligible to appear in the University Examination.

8.0 Examination :

- 8.1 Following University Examinations shall be held at the end of each semester :

8.1.1 M. Tech. First year

- 8.1.1.1 I semester.
8.1.1.2 II semester

8.1.2 M. Tech. Second Year

- 8.1.2.1 III semester
8.1.2.2 IV semester (Project Work only)

- 8.2 Details of subjects and credits shall be prescribed separately as per the scheme duly approved by Academic Council.
- 8.3 University examination shall be held in Nov.-Dec. and May-June, each year.
- 8.4 Failed/absent students shall appear in the subsequent regular university examination as per para 8.3.

9.0 Project Work/Dissertation :

- 9.1.1 Project Work is intended to impart training in research methodology and documentation of research work, which shall culminate in submission of a dissertation for evaluation.
- 9.1.2 Dissertation shall be documentation of original compilation of study material investigations analysis and results etc.

9.2 Selection of Project:

- 9.2.1 Each student shall submit a list of sufficient number of proposed projects, in concerned specialty, to HOD by the end of Semester III.
- 9.2.2 HOD shall assign one of the topics to the student who shall present a detailed synopsis on it, at the start of Semester IV, to a panel comprising of teachers nominated by HOI. Synopsis shall be the blue print for developing the dissertation.

9.3 Guides/Co-Guides.

- 9.3.1 HOD shall nominate Guide for each project/student. Co-Guide(s) may be nominated, if required, by HOD.
- 9.3.2 Guide shall be responsible for rendering guidance and supervision leading to completion of dissertations of quality and giving the certificate that work is done under him duly endorsed and certified by HOD.'

9.4 Appointment and qualifications of External Examiners

External examiner possessing M. Tech. in concerned subject with five years of post. PG teaching experience shall be appointed. Names of external examiners shall be proposed by Dean-Faculty from a panel recommended by Board of Studies.

9.5 Role of Internal Examiner :

Role of Internal Examiner Subject teacher for practical subjects and project guide for the project work shall be appointed as Internal Examiner by the Dean-Faculty Internal Examiner shall certify the genuineness of the candidate and shall be responsible for the smooth conduct of the examination.

9.6 Submission of Dissertation :

Students shall submit three hard and one soft copy of dissertation duly authenticated by HOI, HOD, Guide and Co-Guide to University through HOI by stipulated date in semester IV.

10.0 Promotion :

10.1 A student admitted to Master of Technology course shall be promoted and / or allowed to kjeep term (ATKT) as per following criteria :

10.1.1 Student shall be allowed to keep term for Semester II if he/she appears and fails or does not appear in Semester I examination (subject to the condition that student has filled the examination form).

10.1.2 Student shall be allowed to keep term(s) for Semester III examination even if he/she fails in a total of not more than two subjects of Semester I and II examinations taken together.

10.1.3 Project Report, to be submitted in Semester IV, shall be evaluated by the external examiner only after the student passes all subjects of Semester I, II and III.

11.0 Criteria for passing and Improvement of Grad(s) :

12 Provision for improvement of Grads(s) for students having SCGPA less than 5.0 :

Students shall be permitted to improve their grads under following conditions—

12.1 The facility for improvement in the grades will be available only to those students who have SGPA less than 5.0 and more than 4.0, in-spite of passing in all subjects.

12.2 A subject for improvement in the grade can be undertaken only once within two years of the first time earning the grade D in the subject (i. e. maximum of two papers/subjects) and before finishing the degree program.

12.3 Additional fee will be paid by the student for undertaking each subject/paper for grade improvement (i. e. fees structure for ATKT examination will be applicable).

12.4 After the final result of the subject/paper, the higher grade achieved out of the two shall be considered as the final grade.

12.5 Students having undertaken improvement of grade option will not be eligible for the award of any medal/merit position.

13.0 Internal Assessment/Mid-Sessional Tests :

13.1 Two mid semester examinations shall be conducted in each semester.

13.2 Best marks out of the two examinations shall be considered.

14.0 Scheme of University Examination and Evaluation :

The distribution of weight-age of the various components of evaluation for each subject shall be as follows :—

14.1 Theory

14.1.1. Class quiz/Assignment/Seminars and Attendance	15%
14.1.2 Mid-semester test	15%
14.1.3 Semester Examination	70%

14.2 Practical

14.2.1 Course Work and Attendance	30%

15.0 Grading System :

15.1 Aggregate marks in each subject and total of semester examination shall be converted in equivalent grade for declaration of result :—

15.2 A student shall be awarded Grade in each subject/paper based on his/her evaluation of performance in University examination,

15.3 Numerical equivalents of grade shall be as under —

15.4 Semester Grade Points Average (SGPA) and Cumulative Grade Point Average (CGPA) shall be calculated as follows :—

$$SGPA = \frac{\sum_{i=1}^{\pi} c_i p_i}{\sum_{i=1}^{\pi} c_i}$$

Where c_i is the number of credits offered in the i^{th} subject of a Semester for which SGPA is to be calculated, p_i is the corresponding grade point earned in the i^{th} subject, where $i=1, 2, \dots, n$, are the number of subjects in that semester.

$$CGPA = \frac{\sum_{j=1}^{\pi} SG_j NC_j}{\sum_{j=1}^{\pi} NC_j}$$

Hence NC_j is the number of total credits offered in the j^{th} semester, SG_j is the SGPA earned in the j^{th} semester, where $j=1, 2, \dots, m$, are the number of semesters in that course.

15.5 Grade sheet, issued at the end of each semester, shall indicate SGPA of that semester. Final Grade sheet, issued at the end of final semester of the course shall also indicate CGPA, Equivalent Percentage Marks and Division awarded.

16. Retotaling and Revaluation :

16.1 Retotaling and Revaluation shall be permissible only for theory paper.

16.2 The University on application and remittance of a stipulated fees, shall permit retotaling.

16.3 The University on application and remittance of a stipulated fees, shall permit revaluation in maximum 2 (two) theory papers.

17.0 Award of division :

Division shall be awarded, only after Semester IV examination, based on integrated performance of two years (4 semesters), as follows :—

CGPA	Division
$7.5 \leq CGPA$	First Division with distinction
$6.5 \leq CGPA < 7.5$	First Division
$5.0 \leq CGPA < 6.5$	Second Division

17.2 Conversion from grade to an equivalent percentage in a given academic program shall be according to following formula.

$$\% \text{ Score} = CGPA \times 10$$

18.0 Cancellation of Admission :

18.1 Admission of a student may be cancelled under following circumstances.

18.1.1 At any stage, if student is not found qualified, for the Course, as per AICTE norms/guidelines or the eligibility criteria prescribed by the University.

18.1.2 Failing to complete the course within five years of commencement of the course.

18.1.3 Involvement in gross indiscipline in the Institute/University.

ORDINANCE NO. 2(b)(i)**[Ordinance for Master of Technology (M.Tech.) in Engineering Postgraduate Degree Course]**

Hereinafter referred as subsequent/ revised ordinance of ordinance no. 2(b) as published earlier in Madhya Pradesh Gazette Notification at Sr. no. 7 on 17th February 2012 under first ordinance of the University. It has been modified in accordance with power conferred in clause no. 29 of the Madhya Pradesh Niji Vishwavidyalay (Sthapana Avam Sanchalan) Adhiniyam 2007.

1. The higher degree in Engineering of two year (four semester)/ three year (six semester) shall be designated as MASTER OF TECHNOLOGY (M.Tech.) in Engineering in respective branches.
 - (a) The postgraduate degree of Master of Technology (hereinafter called M.Tech.) shall include the branches as under:-
 - (i) Electronics & Communication Engineering (ECE)
 - (ii) Computer Science & Engineering (CSE)
 - (iii) Chemical Engineering (CHE)
 - (iv) Civil Engineering
 - (a) Construction Management (CM)
 - (b) Structural Engineering (SE)
 - (c) Geotechnical Engineering (GE)
 - (v) Mechanical Engineering
 - (a) Manufacturing Technology (MT)
 - (b) Industrial Engineering & Management (IEM)
 - (vi) Environmental Engineering (ENV)
 - (vii) Biotechnology (BT)
 - (b) The studies and examination of these M.Tech. courses shall be on the basis of the marks-cum-credit system but semester wise and final evaluation shall be by the grading system.
2. Admission
 - (a) Minimum qualification for admission to the first year M.Tech. shall be B.E./B.Tech. in an appropriate branch with at least 60% marks aggregate or its equivalent CGPA from any recognized university/institutions/technical university/Deemed university or any other qualification as recommended by AICTE for a particular course.
 - (b) Applicant of B.E./B.Tech. with CHE/CE branch with 60% or its equivalent CGPA, shall also be eligible for admission in M.Tech. (Environmental Engineering).
 - (c) Applicants possessing a valid GATE Score shall be given preference over those candidates who do not possess a GATE Score for a full time course.
 - (d) Applicants who do not possess a GATE Score, will have to appear in the University Entrance Examination, if such an examination is conducted by the University.
 - (e) Three years M.Tech. degree course will be applicable only to Industry sponsored candidates who have two years experience in the relevant field.
 - (f) Admissions shall be done in the university based on merit.
 - (g) The admissions to M.Tech. course shall be governed by the rules of UGC/AICTE or the Govt. of Madhya Pradesh or any other competent authority.

3. Promotion to Higher Semester and Year

A candidate who has been admitted in the M.Tech. engineering course will be promoted to the higher class in accordance with the following rules:-

- (a) A candidate who has taken admission in the M.Tech. course and has appeared in the examination of the odd Semester of a particular year, will automatically be promoted to the even Semester of the year irrespective of failing in any number of subjects of the previous semester.
- (b) A candidate must have CGPA of at least 5.0 at the end of the year (after even semester in each year) to be declared promoted to the next academic year irrespective of failing in any number of subjects in the previous semesters on conditions of registering the backlog courses first which would run concurrently in the newly registered semester. In such cases, course credit limit should not be beyond as prescribed by the University. In case of failure, the student will be required to repeat the year.
- (c) To pass a particular course of the M.Tech. degree, the minimum required grade is D for both theory and practical examination separately.
- (d) In the M.Tech. course, theory and practical courses shall be counted separately and the weightage of evaluation for both the courses shall be separate.
- (e) For successful completion of the degree, a minimum of 72 course credits, or as defined for the respective admission year by the university, shall be required.
- (f) For the award of a degree, the minimum requirement of Cumulative Grade Point Average (CGPA) will be 5.0.

4. Award of Credits and Grades

- (a) Each course, along with its weightage in terms of units and equivalent credits, shall be recommended by the Boards of Studies concerned and shall be approved by the Board of Management, Academic Council and the Governing Body. Only approved courses can be offered during any semester.
- (b) A student shall be continuously evaluated for his/her academic performance in a subject through Lectures, Tutorial work, practicals, home assignments, mid-semester tests, field work, seminars, quizzes, end-semester examinations and regularity, as proposed by the respective Board of Studies and approved by the Academic Council and the Governing Body of the university.
- (c) The distribution of weightage/marks for each component shall be decided by the respective Board of Studies and approved by the Academic Council and the Governing Body of the University.
- (d) Practical training and project work shall be treated as practical subjects.

- (e) Each student, registered for a course, shall be awarded a grade by the faculty/course coordinator (s) concerned with the specific subject/paper. The grades awarded to a student shall depend upon his/her continuous evaluation through performance in various examinations, assignments, quizzes, laboratory work, class work, mid-semester tests, thesis, project work and regularity.

5. Duration of a Course

- (a) There shall be at least eighteen weeks of teaching in every semester.
- (b) One lecture/tutorial hour per week per semester is assigned one credit.
- (c) One laboratory hour per week per semester is assigned half a credit.
- (d) Some courses are without credit and are referred to as non-credit (NC) courses.
- (e) The maximum duration of the course shall be three year. In the special cases, fixed duration may be condoned by the Vice Chancellor.

6. Attendance

Candidates appearing as regular students for any semester examination are required to attend 80% of the lectures delivered and the practical classes held separately in each subject of the course of study, provided that a short fall in attendance upto 10% and further 5% can be condoned by the Vice-Chancellor of the University.

7. Medium of Instruction and Examination

- (a) The medium of instruction and examination shall be English throughout the course of study.
- (b) The subjects to be studied in different semesters of Master of Technology shall be as per the schemes, approved by the Board of Studies.

8. General

Notwithstanding anything contained in these Ordinances and Regulations, all the M.Tech. Scholars will be governed by the rules and procedures framed by the University regarding this matter, and on matters of general discipline, and implemented from time to time.

9. This supersedes Ordinance No.-2(b) of the First Ordinance of the University, published in Gazette Notification of Govt. of Madhya Pradesh at Sr. no. 7 on 17th February 2012.

ORDINANCE NO. 23**ORDINANCE FOR FIVE YEARS (TEN SEMESTERS)
INTEGRATED B.A. L.L.B. DEGREE COURSES*****Course & Faculty***

1. This ordinance shall be applicable to the Bachelor of Laws (abbreviated B.A, L.L.B.), an undergraduate, or bachelor integrated five year degree in law. This degree is a qualifying degree for practice of legal profession in India. This course shall be run on semester system.
2. This course shall be run by the Faculty of Law after getting the approval of Bar Council of India (BCI) and shall follow the norms laid down by BCI therefore.

Duration

3. The Duration of the Degree of Bachelor of law B.A.L.L.B. Shall comprise a course of study spread over a period of five academic years (ten semesters) and candidate will have to be a full time student.

Intake & Fees

4. The intake shall be decided on the seats approved by the BCI. Multiple classes can be setup as per the approval granted from the respective authority.
5. Lateral entry would be permitted in Third Year of the Course to graduates and post-graduates in any discipline as prescribed by Bar Council of India after the entrance test depending on availability of seats and the number of such candidate should ordinarily not exceed 1/3 of the regular candidates.
6. NO candidate shall be admitted to Second/ Third/ Fourth/ Fifth/ Sixth /Seventh/ Eighth/ Ninth semester on transfer unless the same course of study is prescribed in transferring university and prior opinion of Dean / Head of the Department is obtained.
7. The fees of the courses shall be decided by the Board of Management of the University from time to time subject to the approval of the regulatory body.

Academic Year

8. There will be two academic cycles every year, one from July to June and second from January to December.

Eligibility

9. Candidates seeking admission to the five year integrated B.A.L.L.B. Course must have passed the Higher Secondary School examination (10+2) system or an equivalent examination and secure the aggregate marks/ grade not less than 50% of total marks or equal in all the core subjects and English Language put together.
 - (a) Eligibility and age for admission in B.A.L.L.B. degree, will be as per prevailing norms of BCI.
 - (b) The Minimum qualifications for admission to a course in case of candidates belonging to scheduled castes & scheduled tribes categories will be relaxed by 5%.

Candidates appearing for the 12th examination and awaiting for their results can apply. They will have to provide proof of passing the examination within 30 days of admission.

Admission Procedure

10. Admission under this courses will be made as follows:
- (a) The University will issue admission notifications in news papers, on the University's website, notice board of the university and in other publicity media before the start of every cycle.
 - (b) List of candidates provisionally selected for admission /shortlisted based on merit/ Entrance Examination marks will be displayed on the notice board of the University/ University's website/or the students will be informed directly of their admission after the last date of application.
 - (c) The candidates whose results of the qualifying exam are awaited can also apply who will be admitted provisionally. Such candidates, however, must produce the previous year mark sheet /School/College certificates, as a proof for required eligibility criteria before the due date failing which, the provisional admission cannot be granted. The candidate so admitted shall have to be present mark sheet of the qualifying examination within a month of the due date of admission, failing which the provisional admission shall be cancelled.
 - (d) If a candidate admitted provisionally under (c) above could not obtain the marks to fulfill the requirements & eligibility criteria of the admission the provisional admission granted to him will be cancelled.
 - (e) The application form may be rejected due to any of the following reasons :
 - o The candidate does not fulfill the eligibility conditions
 - o The prescribed fees is not enclosed.
 - o The application form is not signed by the candidate and his/her parent guardian, wherever required.
 - o Supporting documents for admission are not enclosed.
 - (f) Enrollment / Registration number will be assigned to the student by the University after verification & submission of all the necessary documents/fees.
 - (g) Admission rules as framed by the University shall be applicable for all admissions from time to time.

Course Structure

11. The under graduate course in semester system shall consist of:
- a. Such courses (papers) as prescribed by the University
 - b. Such job assignments, internship, moot court, projects etc. as may be prescribed by the University and
 - c. Such scheme of examination as prescribed, by the University from time to time.
12. The course curriculum shall be approved by the concerned Board of Studies and the Academic council of the University. The Academic council of the University on the recommendation of the concerned Board of Studies may change number of papers and /or marking scheme of the course after the due approval of Vice chancellor.
13. Each semester course shall be conducted in not less than 18 weeks with not less than 30 class-hours per week including tutorials, moot court, seminars provided there shall be at least 24 lecture hours per week as presented by Bar Council of India.

14. Number of core subjects in a semester will not be less than 3 (three) and will not be more than 5, including of foundation course (if any).

Medium Of Instructions And Examinations

15. The medium of instructions and examinations shall be either Hindi or English.

Examination Scheme

16. No candidate shall be allowed to take the term-end Semester Examination unless one has:

- (i) Attended at least 75% of lectures / practical delivered.
- (ii) Paid all the fees due
- (iii) Obtained 'No Dues' certificate from the concerned Department/college.
- (iv) Submitted the job internship certificate / Project Report, as notified by the Director/ Head/ Principal.
- (v) Received in-plant training as prescribed by the Director/ Head/ Principal.

Clause (i) above shall not be applicable to Ex-student candidates

17. Each student shall have to appear in the examination of theory/practical and continuous comprehensive examination system (CCE)/internal assessment. The internal assessment will be held in the manner prescribed from time to time by the University.
- (a) 20 per cent marks of each paper will be earmarked of internal assessment (for each semester, there will be two separate evaluations of 15 marks each).
 - (b) Main examination will carry 80 percent marks,
 - (c) For passing the examination; the candidate that be required to secure at least 40% marks in University examination separately in the term-end Theory, practical and Internal Assessment in each of the prescribed paper and aggregate of 50% in the subject(sum of theory and practical marks).
 - (d) There will be an external examiner to evaluate the project report. The minimum passing marks for project work will be 50%.
 - (e) Each student shall have to complete 12 weeks internship for five year course during V to X semester provided that internship in any year cannot be for a continuous period of more than four weeks.

Promotion to Next Semester & Failed Candidate

(i) From odd semester to even semester :

A candidate shall who has appeared in the odd semester (Theory and practical) examination in any particular year shall be promoted to an even semester of the year, irrespectively of failing in any number of theory paper and practical examination of that semester.

(ii) From even semester to odd semester :

A candidate who has appeared in the even semester (Theory and practical) examination in any particular year shall not be promoted to next semester and higher class, if he carries a backing of more than two papers.

(iii) Ex-studentship :-

Subject to the general rule of promotion a candidate shall become ex-student irrespectively of failing in any number of theory papers and practical examination of that year.

Allocation of Division

18. Division shall be awarded only after the tenth and final semester examination, based on integrated performance of the candidate for all the five years. The Division shall be awarded on the basis of Marks obtained in Internal Assessment and University examination (Theory and Practical Both) taken together.

Kulpati Grace of one mark will be given for Pass/ATKT in each semester and for improvement in division in final semester.

Merit Lists

ORDINANCE NO. 24**ORDINANCE FOR THREE YEARS (SIX SEMESTERS)
LL.B. DEGREE COURSES*****Course & Faculty***

1. This ordinance shall be applicable to the Bachelor of Law (abbreviated LL.B), an undergraduate, or bachelor degree in law of three years duration. This degree is a qualifying degree for practice of legal profession in India. This course shall be run on semester system.
2. This course shall be run by the Faculty of Law after getting the approval of Bar Council of India (BCI) and shall follow the norms laid down by BCI therefore.

Duration

3. The Duration of the Degree of Bachelor of law (LL.B.) Shall comprise a course of study spread over a period of three academic years (six semesters) and candidate will have to be a full time student.

Intake & Fees

4. The intake shall be decided on the seats approved by the BCI. Multiple classes can be setup as per the approval granted from the respective authority.
5. NO candidate shall be admitted to Second/ Third/ Fourth/ Fifth/ Sixth semester on transfer unless the same course of study is prescribed in transferring university and prior opinion of Dean / Head of the Department is obtained.
6. The fees of the courses shall be decided by the Board of Management of the University from time to time subject to the approval of the regulatory body, if any.

Academic Year

7. There will be two academic cycles every year, one from July to June and second from January to December.

Eligibility

8. Candidates seeking admission to the three year LL.B. course must have passed the Bachelors Degree examination in any subjects or an equivalent examination and secure the aggregate marks/ grade not less than 45% of total marks or equal in all the core subjects and English Language put together.
 - (a) Eligibility and age for admission in LL.B. degree will be as per prevailing norms of BCI.
 - (b) The Minimum qualifications for admission to a course in case of candidates belonging to scheduled castes & scheduled tribes categories will be relaxed by 5% of the maximum marks.

Candidates appearing for the eligibility examination and awaiting for their results can apply for admission in the LL.B. course. They will have to provide proof of passing the examination within 30 days of admission.

Admission Procedure

9. Admission under this courses will be made as follows:
- (a) The University will issue admission notifications in news papers, on the University's website, notice board of the university and in other publicity media before the start of every cycle.
 - (b) List of candidates provisionally selected for admission /shortlisted based on merit/ Entrance Examination marks will be displayed on the notice board of the University/ University's website/or the students will be informed directly of their admission after the last date of application.
 - (c) The candidates whose results of the qualifying exam are awaited can also apply who will be admitted provisionally. Such candidates, however, must produce the previous year mark sheet /School/College certificates, as a proof for required eligibility criteria before the due date failing which, the provisional admission cannot be granted. The candidate so admitted shall have to be present mark sheet of the qualifying examination within a month of the due date of admission, failing which the provisional admission shall be cancelled.
 - (d) If a candidate admitted provisionally under (c) above could not obtain the marks to fulfill the requirements & eligibility criteria of the admission the provisional admission granted to him will be cancelled.
 - (e) The application form may be rejected due to any of the following reasons :
 - o The candidate does not fulfill the eligibility conditions
 - o The prescribed fees is not enclosed.
 - o The application form is not signed by the candidate and his/her parent guardian, wherever required.
 - o Supporting documents for admission are not enclosed.
 - (f) Enrollment / Registration number will be assigned to the student by the University after verification & submission of all the necessary documents/fees.
 - (g) Admission rules as framed by the University shall be applicable for all admissions from time to time.

Course Structure

10. The LL.B. course in semester system shall consist of:
- a. Such courses (papers) as prescribed by the University
 - b. Such job assignments, internship, moot court, projects etc. as may be prescribed by the University and
 - c. Such scheme of examination as prescribed, by the University from time to time.
11. The course curriculum of the course shall be approved by the concerned Board of Studies and the Academic council of the University. The Academic council of the University on the recommendation of the concerned Board of Studies may change number of papers and /or marking scheme of the course after the due approval of Vice chancellor.
12. Each semester course shall be conducted in not less than 18 weeks with not less than 30 class-hours per week including tutorials, moot court, seminars provided there shall be at least 24 lecture hours per week as presented by Bar Council of India.

13. Number of core subjects in a semester will not be less than 4 (four) and will not more than 6 (six), including of foundation course (if any).

Medium Of Instructions And Examinations

14. The medium of instructions and examinations shall be either Hindi or English.

Examination Scheme

15. No candidate shall be allowed to take the term-end Semester Examination unless one has:
- Attended at least 75% of lectures / practical delivered.
 - Paid all the fees due
 - Obtained 'No Dues' certificate from the concerned Department/college.
 - Submitted the job internship certificate / Project Report, as notified by the Director/ Head/ Principal.
 - Received in-plant training as prescribed by the Director/ Head/ Principal.
- Clause (i) above shall not be applicable to Ex-student candidates
16. Each student shall have to appear in the examination of theory/practical and continuous comprehensive examination system (CCE)/internal assessment. The internal assessment will be held in the manner prescribed from time to time by the University.

 - Each student shall have completed 12 weeks internship for three year course during III to VI semester provided that internship in any year cannot be for a continuous period of more than four weeks.

(iii) Ex-studentship :-

ORDINANCE NO. 25**ORDINANCE FOR ONE YEAR (TWO SEMESTERS)
LL.M.DEGREE COURSES*****Course & Faculty***

1. This ordinance shall be applicable to the Master of Laws (abbreviated LL.M.), a Post Graduate One year degree in law. This course shall be run on semester system.
2. This course shall be run by the Faculty of Law, after due approval of BCI and shall follow the norms laid down by BCI therefore.

Duration

3. The Duration of the Degree of Master of Law LL.M. Shall comprise a course of study spread over a period of one academic year (two semesters) and candidate will have to be a full time student.

Intake & Fees

4. The intake shall be decided by the Board of Management of the University. Multiple classes can be setup.
5. The fees of the courses shall be decided by the Board of Management of the University from time to time.

Academic Year

6. There will be two academic cycles every year, one from July to June and second from January to December.

Eligibility

7. Candidates seeking admission to the one year LL.M course must have passed the Bachelors Degree in Law (LL.B.) or any other equivalent qualification, as approved by BCI.
Candidates appearing for the Final Semester of LL.B. examination and awaiting for their results can apply. They will have to provide proof of passing the examination within 30 days of admission.

Admission Procedure

8. Admission under this courses will be made as follows:
 - (a) The University will issue admission notifications in news papers, on the University's website, notice board of the university and in other publicity media before the start of every cycle.
 - (b) List of candidates provisionally selected for admission /shortlisted based on merit/ Entrance Examination marks will be displayed on the notice board of the University/ University's website/or the students will be informed directly of their admission after the last date of application.

A candidate shall who has appeared in the First semester (Theory and practical) examination shall be promoted to Second semester of the year, irrespectively of failing in any number of theory paper and practical examination of that semester.

(iii) Ex-studentship:-

Subject to the general rule of promotion from first semester to second semester a candidate shall become ex-student if he/she could not get success in any of the paper of either semester irrespectively of failing in any number of theory papers and practical/project examination.

Allocation of Division

15. Division shall be awarded only after the second and final semester examination, based on integrated performance of the candidate for all the two semesters. The Division shall be awarded on the basis of Marks obtained in Internal Assessment and University examination (Theory and Practical Both) taken together.

60% or above	-	First Division
50% or above but less than 60%	-	Second Division

Kulpati Grace of one mark will be given for Pass/ATKT in first semester and for improvement in division in final semester.

Note :- (i) No third division shall be awarded.

- (ii) Candidate who obtained 75% or more marks in aggregate shall be declared to have passed the LL.M. degree course in First division with distinction.
