## MADHYA PRADESH BILL

No. 13 of 2016

**THE MADHYA PRADESH NIJI VISHWAVIDYALAYA (STHAPANA AVAM SANCHALAN) SANSHODHAN VIDHEYAK, 2016**

**A Bill further to amend the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007.**

Be it enacted by the Madhya Pradesh Legislature in the sixty-seventh year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhiniyam, 2016.

Amendment of Schedule.

2. In Schedule to the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007) after serial number 20 and entries relating thereto, the following serial numbers and entries relating thereto shall be added, namely:—

Repeal and Saving.

3. (1) The Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhyadesh, 2016 (No. 2 of 2016) is hereby repealed.

(2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance shall be deemed to have done or taken under the corresponding provisions of this Act.

## STATEMENT OF OBJECTS AND REASONS

In Section 5 of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), it is provided that the Regulatory Commission constituted under the Act shall evaluate the proposal of establishment of Private University in the State. In the light of the said provision, the Regulatory Commission has recommended to establish the Private Universities, namely, G. H. Rasoni University, District Chhindwara, D. C. University, Indore and Symbiosis University of Applied Sciences, Indore. In the light of Section 6 of the said Act, the State Government have issued the letter of intent to the sponsoring bodies of the said Universities, with regard to the establishment of the said Universities, Section 9 of the said Act provides that after being satisfied on considering the report submitted by the Regulatory Commission, Private University shall be established by incorporating the name and description thereof in the Schedule to the said Act.

2. As the matter was urgent and the Madhya Pradesh Legislative Assembly was not in session, the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhyadesh, 2016 (No. 2 of 2016) was promulgated for the purpose. It is now proposed to replace the Said Ordinance by an Act of State Legislature without any modification.

2. Hence this Bill.
