Part - IV - Recommendations

A. Observations of the Committee

- Sri Satya Sai University of Technology and Medical Sciences was established in the year 2013. In the span of five years, the university located in about 70 acres of land, acquired a reasonably good infrastructure like class rooms, administrative block, laboratories etc. However, shortfalls are still there which needs attention on priority basis. For eg. There is no auditorium, seminar hall in the campus. Similarly, a central library with good collection of books, journals, reference books, ejournals, e-books etc. are required. Toilets are few and farther. Buildings are not differently abled friendly. Elevators are not available in any of the blocks. Other facilities lacking in the campus, pointed out by the students during interaction are clean drinking water, fire extinguisher in all buildings, ramps, more toilets, incinerator in ladies hostel etc.
- There are four schools offering courses in Education and Physical Education and three schools offering courses in Pharmacy. These schools were functioning as colleges prior to the establishment of Sri Satya Sai University of Technology and Medical Sciences. After the establishment of University, these schools are still functioning as separate constituent units of the University. As a result, resources are not put to use in a rational way.

- University needs further upgradation. Student enrollment and attendance especially in Hotel Management is poor.
- Paramedical teaching process should be structured. Attendance of students should be improved substantially. Exposure to clinical areas should be assured for all students.
- Infrastructure facilities, equipment, laboratories etc. in the School of Education, Physical Education, Engineering and Hotel Management are of moderate in nature.
- In several departments, the number of teachers in position reported by the university could not be verified because of lack of documents.
- The University should initiate steps to apply for accreditation from NAAC. Similarly, the university should also aim to obtain accreditation by NBA.
- Given that the University is located in a rural area and considering the drop-out rate, the Committee suggests that the University should introduce bridge/remedial courses for the benefit of rural students.
- The University should offer degrees specified by UGC under Section 22. For eg. degrees offered in the university such as Bachelor of Medical Lab Technician (BMLT) and Bachelor of Library and Information Technology are not seen in the list of specified degrees published by UGC in 2014.
- The IQAC in the University needs to be strengthened and work more actively
- The State Act to establish the private university is an important document. Functioning and governance structure of the private university should be as per the provisions of the Act. The Committee found from the copy of the Act submitted by the University that one page (page no. 32) is missing. The Committee suggests that the University should work with the State Government authorities to address the issue.
- Central instrumentation facilities must be strengthened. Placement cell activities needs improvement
- University should try to organize more seminar, conferences, workshops
- Industry-institution interaction needs to be improved
- There is a requirement of more faculty members in the engineering departments. Further, the faculty cadre ratio needs to be maintained and short fall of qualified faculty need to be addressed

- Rational restructuring of various colleges and units under the university by merging them into departments is necessary. This was one of the recommendations of the previous UGC Committee 1. you is required to be improved also.
- Qualified faculty cadre ratio may be updated as per the rules of the Councils concerned 2.
- IQAC need to be strengthened 3.
- Following infrastructural facilities should be improved: 4.
 - Sufficient and identified toilets in all the blocks for the students as well as faculty
 - Drinking water facility should be made available in all the blocks
 - Elevators should be installed in all the blocks

 - Sufficient hostel facilities for students and quarters for staff may be created

The Committee, after verifying the documents submitted by the University, physically visiting various departments interacting with students, teachers and non teaching staff and other stakeholders, recommends that the approval letter may be granted to Sri Satya Sai University of Technology and Medical Sciences, Sehore, M.P, subject to the compliance of suggestions made at Section B above.
